Hal called the Zoom meeting to order at 5:04pm with seven towns represented.

- 1. **Minutes** of the December 14 meeting was approved as written.
- 2. Financial Report was approved.
- 3. Old Business:
 - Getting CSH programming on the access channels Esme looked into using TelVue to transmit CSH programs to the Greenwich feed, but reported that it would not work for this purpose.
 - Return of Weston Equipment Doug reported that claimed equipment has been distributed.
 The list of remaining equipment will be updated after adjusting for inoperable items. After which the remaining unclaimed items will be disposed of by some means.
 - Invoices were sent to Altice for \$2K Council funding and \$100K +\$25K for 2023 E&G funding. These were paid on 1/27/23.. A request for Uverse pass through E&G funds TBD was also made. These funds will be used for Round 2 grants.
 - The A9CC Annual Report was filed with PURA on 1/6/23 and distributed to Council members, Area 9 town CEO's & schools superintendents.
 - 2022 I-net reports due 2/1/23. Owed E: *Greenwich, *Norwalk, Region 9, *Stamford, *Weston, NCC, CSH; G: Easton, *Greenwich, *Stamford, *Weston; Wilton. Towns & schools that have not submitted I-net reports or program logs will not be eligible for 2023 grants.
 - * indicates no grants taken in 2022.
- 4. **2022 Round 2 grant program:** A request from Darien G was approved to reallocate \$342.10 in funds received in 2022 Round 2 from equipment to operations (camera operators).

5. 2023 Round 1 grant program:

Round 1 grants based on ~\$130K funding income. Unused Round 1 funds + UVerse funds will be used for round 2 grants. The following was adopted:

- \$65,025 each to E & G
- 9 grants of \$7,225 on the Government side (Weston has opted out)
- Breakdown of the Educational portion to be determined by the Ed Committee
- A maximum of \$3,000 for each grant could be allocated to operations
- The deadline for submitting grants from the towns is May 17
- The deadline for submitting grants from the schools is September 14
- Unused Round 1 funds retained separately in E&G funds for Round 2 grants
- Eligibility requirements as outlined in the Grant Procedures http://a9cc.org/GrantProcedures.pdf shall apply to these grants
- 6. Access Channel Programming Problems and Solutions: Jim discussed problems with uploading program videos due to a 10MBPS upload speed on his Optimum internet service. Optimum advertises its upload speeds to be 1/10 the download speeds for a selected service plan. There was discussion about equipment issues (modems & routers) which could contribute to poor performance. Esme suggested checking Optimum's plan offerings at https://www.optimum.com/.

7. Other Matters

- Mike made a request to Altice for \$6,000 to fund trophies and equipment prizes for this year's Education Access Awareness Awards. Esme will present it to the company.
- Mike commended Altice on the recent fiber construction at Joel Barlow High School in Redding.
